# CERTIFICATE OF FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR HUNTINGTON PHASE II

This Amendment constitutes the First Amendment to Declaration of Covenants, Conditions and Restrictions for Huntington Phase II, which was originally recorded in Official Records (O.R.) Book 1990, Page 466, in the Public Records of Seminole County, Florida ("Declaration");

#### WITNESSETH, That

WHEREAS, the Members of the Association wish to amend Article V, Article VII, Sections 2, 4, 5, 10 and 18(c) and Article XI, Section 5 of the Declaration; and

**WHEREAS**, the Declaration provides for the same to be amended by an instrument signed by not less than seventy-five (75%) of both classes of members.

**NOW THEREFORE**, the Members hereby amend the Declaration as follows: [NOTE: Additions to text are indicated by **bold underline**; deletions by **strikeout**.]

Article V is hereby amended as follows:

Except as otherwise provided herein, Nno building, fence, walls, exterior antennas, satellite dishes, or other structure shall be commenced, erected, or maintained upon the Declaration Property or any portion thereof, nor shall any exterior addition to, change or alteration, including exterior coloring, be made nor shall any tree removal, landscaping and additional landscaping, fences or changes in existing fences, hedges, walls, walkways and other structures be commenced until the plans and specifications showing the nature, kind, shape, height, materials, color, approximate cost and location of the same shall have been submitted to and approved in writing as to harmony of exterior design and location in relation to surrounding structures and topography by the Board or by an Architectural Control Committee composed of three (3) or more representatives appointed by the Board. In the event the Board, or its designated committee, fails to approve or disapprove such design and location within thirty (30) days after said plans and specifications have been submitted to it, approval will not be required and this article will be deemed to have been fully complied with.

Article VII, Sections 2, 4, 5, 10 and 18(c) are hereby amended as follows:

Section 2. Vehicular Parking. No vehicle shall be parked on any part of the Declaration

Property, except on paved streets and paved driveways. No vehicles may park on paved streets overnight at any time between the hours of 12:00 a.m. to 6:00 a.m. for more than three (3), consecutive or non-consecutive, days within a seven (7) day period. No commercial vehicles shall be parked in the Development, unless parked inside garages and concealed from public view, except those present on business and law enforcement vehicles. No motorcycles, trailers, boats, campers, trucks, mobile homes, or motorized recreational vehicles may be parked in the Development unless parked inside garages and concealed from public view. No inoperative automobiles, trucks, trailers or other types of vehicles shall be allowed to remain either on or adjacent to any Lot for a period in excess of forty eight (48) hours, unless parked inside garages and concealed from public view. There shall be no major repairs performed on any motor vehicle on the Declaration Property.

Minor repairs will be permitted on Lots such as changing oil and changing a tire.

- (a) The term "Commercial Vehicle" shall include any vehicle:
  exceeding 21.5 feet in length or 8 feet in height; having commercial advertising
  displayed on the body of the vehicle; having ladders or materials projecting from or
  hanging on the body of the vehicle; or containing construction or foliage debris, trash,
  garbage, or hazardous materials.
- (b) The term "Inoperative Vehicle" shall be defined as any vehicle which does not have a current license plate, or any vehicle that cannot start, or any vehicle with a flat tire for a continuous period in excess of seventy-two (72) hours, within a one (1) week period.
- (c) <u>The Association is specifically authorized to promulgate additional</u>
  Rules and Regulations defining the terms herein.
- (d) The Association is specifically authorized to promulgate additional Rules and Regulations pertaining to parking matters and all vehicles.

#### Section 4. Signs.

- (a) Except as otherwise permitted herein, no sign or any character shall be displayed or placed upon any Lot, except "For Sale" or "For Rent" signs, which may refer only to the particular Lot on which displayed, and shall not exceed thirty-six inches (36") by twenty-four inches (24"), and except commercial signs of contractors or subcontractors who are working on a Lot or any improvements to a Lot, provided such commercial signs shall not exceed thirty-six inches (36") by twenty-four inches (24"). Said commercial signs shall only be located on the Lot during the period that the contractor or subcontractor is working on a Lot or any improvements to a Lot; however, such time period may not exceed ninety (90) days.
- (b) Nothing contained in this Declaration shall prevent Declarant, or any person designated by Declarant, from erecting or maintaining such commercial and display signs as Declarant may deem advisable for development purposes, provided such are in compliance with the appropriate governmental regulations applicable thereto.

Aerials. No exterior radio or television mast, tower, pole, wire, aerial, Section 5. satellite receiving stations or dish, antenna or appurtenances thereto, shall be erected on any Lot, except those that are specifically permitted by Federal or State Law. The Association shall have the authority to adopt Rules and Regulations governing the appearance and installation of the antennas and/or satellite dishes, permitted by Federal or State law, including but not limited to, the specific placement, location of wiring. general appearance and color of the antenna and/or satellite dish. The Owners shall be responsible for maintaining the antennas and/or satellite dishes in a clean, neat, and usable condition.

Section 10. Laundry. Unless prohibited by Federal or State law, Cclotheslines are not permitted unless they are completely hidden from view of person off the Lot. No clothing, bedding or other laundry shall be hung over or on any windows, doors, walls, fences or other supports if the same are visible from any street.

Section 18. Minimum House Size.

No projections of any type shall be placed or permitted to remain above any roof of the dwelling with the exception of one or more chimneys or vent stacks. No solar collectors shall be visible from any front street. Solar collectors are permitted; however, the Association shall have the authority to adopt Rules and Regulations regarding the location, general appearance and color of the same; provided, such Rules and Regulations do not impair the effective operation of the solar collector. Solar collectors should not be visible from any front street, if possible. The Owners shall be responsible for maintaining the solar collectors in a clean, neat and usable condition.

Article XI, Section 5 is hereby amended as follows:

Amendment and Termination. The covenants and restrictions of this Section 5. Declaration shall run with and bind the land for a term of thirty (30) years from the date this Declaration is recorded, after which time they shall be automatically extended for successive periods of ten (10) years each, unless within six (6) months prior to the commencement, of any extension period, an instrument in writing executed by the Owners representing seventy-five percent (75%) of the votes has been recorded in the Public Records of Seminole County, Florida which instrument may change, amend, modify, waive or extinguish in whole or in part, as to all or any part of the Declaration Property, the provisions of the Declaration. This Declaration may be amended by a vote of a majority of the voting interests, at an annual or special meeting of the Members during the first thirty (30) year period by an instrument signed by not less than seventy-five percent (75%) of both classes of members. Any amendment must be recorded in the Public Records of Seminole County, Florida.
